Yes, I/We would accept the accidental damage waiver insurance, not including theft @ \$5 per bike/children's equipment per day (no insurance on electric, road, hard tail, full suspension bikes or Comotion tandem).

Blazing Saddles provides and requires free safety helmets. California State law requires helmets for riders less than 18 years of age.

No, I/We am/are financially responsible for damage to the equipment.

I/We refuse/decline to wear the required free safety helmets.

The following is a warning, release of liability, assumption of risk, and indemnity agreement between the renting party (hereinafter collectively referred to as "I"), and the rental company (hereinafter collectively referred to as Blazing Saddles).

1. I acknowledge that bicycling can be a hazardous activity that involves risks that may be injurious or fatal. I willingly agree to assume all risks included in the activity. I acknowledge that Blazing Saddles requires and provides a free helmet per bicycle rented (required by California State law if under 18).
2. I agree to indemnify and hold harmless Blazing Saddles, including owners, officers, agents, employees, volunteers, participants, landlords, tenants, sponsors, advertisers, and any other entity or person acting on their behalf, from any and all liability for damage, injury, or death to myself or to any other person or property, which are in any way connected to my participation in the activity stated herein. I waive my right to present any legal claim or lawsuit against these entities or persons regardless of how any damage, injury, or death may have occurred, through negligence or any other manner considered through legal claim.
3. I agree to release, discharge, indemnify, and hold harmless all manufacturers and/or distributors of any equipment provided to me by Blazing Saddles, including but not limited to bicycles and helmets, from any and all liability for damage, injury, or death to myself, or any other person or property, which are in any way connected to my participation in the activity stated herein. I hereby waive my right to present any legal claim or lawsuit against these entities regardless of how any damage, injury, or death may have occurred, through negligence or any other manner considered through legal claim. I agree to inform Blazing Saddles that the rental bike(s)/equipment is/are satisfactory after initial test ride.
4. I acknowledge that flat tires are an inherent risk of bicycle riding. Blazing Saddles will provide a pump/patch kit to repair flat tires when asked for at beginning of rental period. Blazing Saddles does not compensate for flat tires. I further understand that although roads, routes, and surfaces are suggested to me for riding by Blazing Saddles, they are not owned, monitored, managed, or kept by Blazing Saddles and hence release Blazing Saddles from any responsibility for condition of said areas. I understand that it is unsafe and illegal to ride a bicycle after dark without lights. Blazing Saddles has lights for purchase upon request.
5. I agree to confirm receipt of a lock and key before departing Blazing Saddles rental premises with rental bike(s)/equipment. I acknowledge that it is my responsibility to return said rental bike(s)/equipment under all circumstances and that Blazing Saddles does not provide pickup/rescue service. I understand that Blazing Saddles requires a security deposit of at least \$100/equipment. When a bike is returned, deposits made on credit/debit cards will be released within a period of time dependent upon the policy of my financial institution. I understand and agree that in the event that said rental bike(s)/equipment are lost, stolen, or damaged, to forfeit my security deposit and immediately pay Blazing Saddles the total cost to replace/repair bike(s)/equipment plus any rental charges incurred. I acknowledge that accidental waiver insurance does not cover loss, theft, or abuse of rental bike(s)/equipment. A fee of \$20.00 will be charged for loss of lock key, \$30.00/helmet. For unreturned/abandoned bikes there is a minimum fee of \$30/bike for pick-up. Bicycle damage/loss will be charged based on retail replacement costs that range from \$500-\$3,000 depending on model. MSRP prices are available on manufacturer's website.
6. I understand that Blazing Saddles is not in any way responsible for the scheduling, capacity, punctuality, or any other aspect of ferry boat service.
7. I understand and agree that a 2-hour minimum charge applies to all hourly rentals and that the rental time begins when deposit is submitted. After 2 hours, rentals are calculated on 30 min.-increments with a 5 min. grace period. For bikes in the 24-hour category, the 24-hour minimum applies after the bike has been test-ridden and accepted "as-is".
8. I understand that I must return the bike to the same location from which it was rented during normal business hours for each location; for one-way rentals between the Hyde and Mason Street locations a \$10/bike fee will apply to each rental bike in addition to the daily rental rate. I understand and agree and to call Blazing Saddles before stated closing time to receive instructions on the 24hr drop-off areas. I agree to allow Blazing Saddles to use my image in photographic reproduction and video for advertising/promotional purposes.
9. I agree that this contract is a warning, release of liability, assumption of risk, and indemnity agreement that serves as a legally binding contract. I agree that this contract is intended to serve as comprehensive a release of liability and indemnity agreement as is legally allowed. I agree that if any portion of this contract is found to be void, invalid or unenforceable, the remaining portions shall remain in full force and effect. I agree that this contract shall be binding for myself, my children, my heirs, assigns, executors, and personal representatives and administrators of my and/ or their estate(s).
