HANMER SPRINGS BUNGY - DISCLOSURE OF RISKS & WAIVER FORM

- 1. I understand and acknowledge:
 - 1. Bungy jumping involves an element of risk and that risks exists in the use of the equipment required for bungy jumping and / or my participation in bungy jumping and includes (without been an exhaustive list) physical stress, dangers or hazards which may result in damage or loss of personal articles, accidental injury, illness or in some cases permanent trauma, disability or death (the "Risks").
 - 2. The risks may be caused by the negligence of Hanmer Springs Attractions, Wood Scenic Line Limited or their respective owners, agents, employees, directors or officers (the "Company") or other participants including myself. The Risks may arise from foreseeable or unforeseeable causes including but not limited to the bungy jumping operators decisions, equipment failure, medical conditions or issues which I am either aware or unaware of and any other risks that are integral to adventure activities.
 - 3. The issues and Risks disclosed above cannot be eliminated without destroying the experience and unique character of bungy jumping which I want to experience even after understanding all of the above matters disclosed.
- 2. If you are under 16 years old a parent or guardian must sign this waiver form. Note: minimum requirements for all bungy jumpers are a weight of 35kg and 12 years and over and are correctly fitting the safety harness.
- 3. I confirm that I am in good health and am physically fit and have no medical, physical or other condition that could be affected by the activity of bungy jumping, including (without been an exhaustive list) the following conditions; pregnancy, high blood pressure, heart conditions, neurological disorders, epilepsy, previous dislocations, bone disorders, fragile skin, artificial limbs, asthma or back or eye issues. I understand and accept that although I may consider myself to be in good health that does not guarantee that the act of bungy jumping will not cause or lead to health issues or injuries to myself.
- 4. I hereby consent to receive such medical treatment as may be necessary in the case of any injury, accident or illness incurred during or after the activity of bungy jumping.
- 5. I hereby agree to adhere to all instructions and wear all safety equipment given to me by the Company and acknowledge that the Company reserves the right to cancel the activity or refuse anybody from participating on the basis of compromised safety.
- 6. After understanding all the information provided in this form, I, for myself, my executors, administrators, successors and assigns release, waive, hold harmless and keep indemnified the Company from all claims, losses, damages or expenses incurred during, or in conjunction with my participation in bungy jumping including any claims for loss or injury to a person or equipment caused by equipment failure and / or negligence of the Company, together with any costs including legal fees that my be incurred as a result of any such claims losses, damages or expenses whether properly founded in law or otherwise.

- 7. After understanding all the information provided in this form, I also release, waiver, hold harmless and indemnify the Company against all claims, losses, damages or expenses or any claim that any of my guests, companions, next of kin may have or any one or more of their executors, administrators, successors or assigns may have against any cost including legal fees that my be incurred as a result of any such claims, losses, damages or expenses whether properly founded in law or otherwise
- 8. I agree and undertake that I will not attempt to void the terms and conditions contained in this form hereof by commencing any legal action in any country outside of the jurisdiction of the New Zealand Courts and I hereby accept the law governing this agreement is the law of New Zealand.
- 9. I agree there are no refunds of monies if I decide not to bungy jump, I accept that have 2 minutes to leave the edge of the jump platform due to the complicated nature of Hanmer Springs Attractions multiple activities running consecutively after each other.
